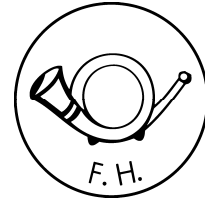

## Nomination Procedures & Information

In accordance with the Fairfax Hunt By-Laws, Article IV, Section 3 and the Rules and Regulations (July 2002):

1. Nominees for Membership shall apply in writing and submit a check for the applicable initiation fee to the Board of Governors (Board) in accordance with Section 11 of the Rules and Regulations.
2. Nominees for Non-Resident Membership must have a primary residence further than seventy-five (75) miles of the Clubhouse and/or kennels.
3. The Board shall establish procedures to evaluate the qualifications for Membership of each candidate.
4. Selection for Membership in the Hunt shall be by a majority vote of the Board.
- 5. A proposed hunting member, not known to the Membership, shall be required to cap with The Fairfax Hunt two (2) times before the board takes action on the application.**
6. New members must pay the applicable annual dues within thirty days after being notified in writing by the Board that their application for membership has been approved. If the nominee participates in a hunting event prior to paying the annual dues, a cap fee must be paid in accordance with Section IV of the Rules and Regulations and will be credited toward the annual dues obligation.
7. It is hoped that all members will volunteer to participate in one or more of the following activities. Please indicate any that you are interested in assisting with:
  - Trail Clearing and Maintenance of Land for Hunting
  - Hunt Races (Management, Advertising, Course Set Up, Parking, Fundraising)
  - Hound Walking
  - Entertainment Committee
  - Hunt Ball Committee
  - Trail Ride Committee
  - Web Page

Please include a check (made payable to The Fairfax Hunt) for the initiation fee (See Schedule Below). If for any reason the application for membership is not accepted, the initiation fee will be returned immediately.
